1. You can cancel this declaration at any time by notifying the Hunstanton Croquet Club.
2. Please notify the HCC if you change your name or address. Gift Aid is reclaimed by HCC in its capacity as a Community Amateur Sports Club (CASC) from the tax you pay for the current tax year. Your current address is required to identify you accurately as a current United Kingdom taxpayer. The completion of this box is accordingly mandatory.
3. Donor Details - This information counts as personal data. As with all personal data held by the Club it is secured under the GDPR regulations and cannot be shared with non-relevant third parties. Her Majesty's Revenue and Customs (HMRC) is a party to this declaration.
4. The data requested in this declaration must match that held by HMRC about you.
5. If your circumstances change and you find that you will no longer pay tax on your income and/or capital gains equal to the tax that the CASC reclaims, you can cancel your declaration, by notifying HCC. If you have to do this, please do so as soon as you become aware of your changed tax position.
6. If you pay Income Tax at the higher or additional rate and want to receive the additional tax relief due to you arising from charitable donations, you must include all your Gift Aid donations on your Self-Assessment tax return or ask HMRC to adjust your personal tax code.
